# 2017 SPE- DETROIT SECTION MATERIAL AUCTION

## Donation Terms and Guidelines

### 1) Virgin Resin Preferred

Full Boxes Only

Prefer Full Skids of Bags or Drums

Packaging must be in good condition

### 2) Freight is the responsibility of the Buyer

Material must be picked up within **60 Days** of the auction. After this time period, the material **will no longer be available.**

### 3) Coordination of payment/release-

Donator to be notified in writing by the Auction committee of the following prior to release.

A) Successful bidder name

B) Payment receipt by the committee. Buyer must pay the SPE within **30 Days** of the auction.

*Note - Once payment is received, an SPE Auction committee member or the APC will issue a fax or an e-mail to the buyer and seller releasing material for pick-up.*

### 4) Utilize attached form as a tax receipt

Company/Individual making donation to establish value and tax period for deduction.

### 5) Material, once donated must be available at the auction

Notify the committee immediately of any changes.

### 6) Use attached donation form only

Provide all required information.
